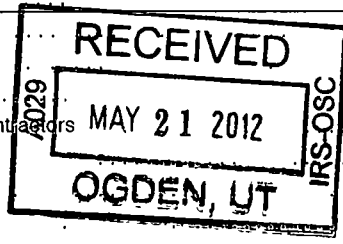

### Primary Purpose

Gateways Music Festival produces bi-annual classical music festivals with African-American musicians from throughout the US in a variety of concerts. The purpose is to increase visibility of African-American classical music contributions; provide role models for young musicians and specifically encourage young African-Americans to study and create additional venues. The 2011 festival provided free performances by seventy musicians including fourteen Chamber Music in the Home concerts; fourteen Sunday Morning Church concerts; a City Hall Special Youth concert; Eastman Theatre and Community Chorus Concerts. Some 4,600 people of all ages and backgrounds, including many more families with children attended concerts. Surveys indicated performances and attendance were the best ever.
